6. Buskers shall perform for a maximum of 2 hours on any one day.
7. Amplification, if proposed, is approved on a trial basis only. Council reserves the right to amend this approval to refuse amplification where there are justified complaints regarding excessive noise.
8. This approval may be revoked at any time if the conditions are not complied with or if the amenity of persons is detrimentally affected for reasons of noise, health or safety.
