- 1. Acknowledge the social, physical, environmental and economic impact the bushfires have had on our community including businesses.
- 2. Acknowledge the tireless work of the:
  - (a) Incident Management Team (NSW Rural Fire Service, Forestry and NPWS) assisted by volunteers, local contractors, visiting firefighters and Council staff.
  - (b) Emergency Operations Centre (NSW Police, Eurobodalla Shire Council, Essential Energy, NSW SES, NSW Ambulance, NSW Disaster Welfare, NSW Local Health District, Transport for NSW, NSW Department of Primary Industries, Agriculture and Animal Services and NSW Local Lands Services.
  - (c) People who worked or volunteers at the three evacuation centres, which assisted over 9,000 people during this period and the Clubs, Health and Aged care facilities and local households who also provided welcome assistance to people who were evacuated.
- 3. Note the actions and advocacy taken to date during the Emergency Response and Recovery phases.
- 4. Receive a supplementary report on the further support and ongoing advocacy that Council can implement for our community and businesses.
- 5. Continue its advocacy for an Integrated Emergency Services Precinct with a purpose build Emergency Operations Centre, further financial support for businesses, additional resources for our community and processes to assist people to regain control over their lives.
- 6. Accept the Commonwealth funding of \$1 million made available under the Disaster Recovery Funding Arrangements Category C (severe impact event funding) in response to the recent bushfires.
- 7. Receive a further report identifying a priority list of projects and programs for consideration in allocating this \$1 million in funding assistance.
