The overall winner was Janine Halasz. Janine has given hundreds of hours of time to community groups such as the Red Cross, Tilba CWA and the Central Tilba School of Arts Trust. She has raised money for various organisations in Eurobodalla such as the Moruya Women's Refuge and Moruya Oncology unit. Janine also established a knitting group which knits blankets for hospitals, beanies for premature babies and items for Aboriginal communities.
