- 1. Council acknowledge that many members of our community are still living in temporary accommodation after the 2019/2020 bushfires.
- 2. Council acknowledge that there is a shortage of accommodation types available to house our community.
- Council note that there is a current exemption within the Local Government
 (Manufactured Home Estates, Caravan Parks, Camping Grounds and Moveable Dwellings)
 Regulation that allows natural disaster affected landowners to reside in temporary
 accommodation (moveable dwellings) for a period of two years and for many this period
 will end sometime this year.
- 4. Council note that the NSW Government has amended the Local Government (Manufactured Home Estates, Caravan Parks, Camping Grounds and Moveable Dwellings) Regulation to allow Councils to develop a Local Approvals Policy that includes provisions for extending the exemption to house natural disaster affected landowners in moveable dwellings on their property.
- 5. Council resolves to allow those members of our community who lost or had their homes severely damaged by the 2019/2020 bushfires to continue to live in temporary accommodation (moveable dwellings) on their property while Council develops a policy position.
