The program aims to reduce water demand and help protect our unique environment. By replacing a single flush toilet with a water efficient dual flush toilet you can reduce your water bill too. Customers can claim rebates for two toilets per residential property and up to 10 per commercial property.

To claim a rebate read the terms and conditions, purchase and install your toilet/s and send in your completed application form and supporting documents to either:

Terms and conditions

- The toilet/s must be installed at a residential or commercial property connected to Council's water supply
- The toilet/s must be installed by a licensed plumber
- The toilet/s must have a water rating of 4 stars or higher as approved by the WELS scheme
- The purchase and installation must be a combination of cistern and pan
- The new toilet/s must replace existing single flush toilet/s
- The toilet/s must have been purchased and installed during the past six months
- A tax invoice for the toilet/s purchase or installation must be provided stating:
 - your name
 - a delivery or installation address in Eurobodalla
 - the toilet/s make and model
 - a \$0 balance owing
- Applicants must be willing to undergo an audit by Council to ensure the toilet/s is/are installed as specified in the application
- Toilets installed to comply with BASIX for new buildings or major renovations are not eligible for a rebate
- Council reserves the right to reasonably deny any application

Payment

Your rebate will be paid by electronic funds transfer into your nominated bank account within 60 days of receipt of your application

Timeframe

The program may be altered or cancelled at any time.

Business operators

The total water efficient rebates paid will not exceed \$2000 per commercially rated property
