## What the water-saving program offers

Eurobodalla Shire Council offers local businesses the free supply and installation of water-saving devices by a licensed plumber. These simple actions can pay big dividends, saving you up to \$1,700 a year in water and energy costs.

Enware Australia - ultra-rinse pre-rinse trigger spray nozzle 	\$400	<ul style="list-style-type: none"> <li>• \$360 (based on 30 minutes of daily use, using 30% hot water).</li> <li>• Built tough for busy commercial kitchens, the chisel-style spray rapidly removes excess food and has a flow rate of 3-6 l/min.</li> </ul>	<ul style="list-style-type: none"> <li>• For businesses only.</li> <li>• Limit of two per business.</li> <li>• Only for replacement of a nozzle with a flow rate of 10 l/min or higher.</li> </ul>

Save water without compromising pressure.</li> </ul>	<ul style="list-style-type: none"> <li>• For businesses only.</li> <li>• Limit of two per business.</li> <li>• To replace existing spray gun or hose nozzle with a flow rate of 20 l/min or higher.</li> </ul>
<p>Water-efficient showerhead</p> 	<p>\$60</p>	<ul style="list-style-type: none"> <li>• \$1,700 (based on eight people using showers for five minutes daily using 30% hot water).</li> <li>• Quality showerhead with a Water Efficiency Labelling Scheme (WELS) rating of three stars and a flow of 8 l/min - saves water without compromising on customer satisfaction.</li> </ul>	<ul style="list-style-type: none"> <li>• Eight available per business (more upon request).</li> <li>• To replace existing showerhead with flow rate of 12 l/min or higher.</li> <li>• For compatible showers only. Water-efficient showerheads are not suitable for low pressure, gravity fed and some instantaneous or continuous supply hot water systems.</li> </ul>

Item	Supply and install cost (approximate)	Annual water and energy saving	Eligibility requirements
<p>Hand-basin tap spout - mounted flow regulator.</p> <p>Water flow control laminar PCA spray - either 1.7 l/min or 2 l/min.</p> 	\$20	<ul style="list-style-type: none"> <li>• \$200 (based on 30 people during traditional business hours).</li> <li>• Spout-mounted flow regulators reduce flow rates to as much as 2.5L/min, while still providing an adequate flow and spread of water. Council uses these at our offices, and they are preferred to higher flow taps as their spread is broader.</li> </ul>	<ul style="list-style-type: none"> <li>• For businesses only.</li> <li>• Limit of 60 per business.</li> <li>• To replace existing spout-mounted flow regulator with a flow rate of 9 l/min or higher.</li> </ul>

## Terms and conditions

### General eligibility

1. This program applies to existing businesses connected to the Eurobodalla Shire water supply.
2. The program applies to replacing existing products, not installing new products.
3. The program does not apply to new developments and renovations.

### Product eligibility and program limitations

Eurobodalla Shire Council reserves the right, at its sole and absolute discretion at any time, to change any, or all, of the terms and conditions of the program or cancel the program. The program is subject to the available budget.

1. Council will not pay for any additional works that go well beyond the standard replacement of an existing eligible item.
2. If Council's plumber identifies that works will be well beyond standard replacement costs, then the customer will be notified before any work takes place and will have the option to proceed and to pay extra costs, or to cancel works.
3. The Business Water-Saving Program water-saving devices must be compatible with the equipment onsite.
4. Eurobodalla Shire Council takes no responsibility for plumbing issues relating to the property as a result of the program (see liability clause below).

### Liability

1. As far as the law permits, Eurobodalla Shire Council accepts no liability in respect to any claim, cause of action or loss or damage arising out of, or in relation to, the installation of water-efficient improvements that are the subject of this program.
2. Eurobodalla Shire Council is released by the customer from any claim or liability arising out of, or in relation to, the installation of water efficiency measures that are the subject of the Business Water-Saving Program, to the extent that a claim or liability is not caused by Eurobodalla Shire Council's negligence or breach of this program, or any other term implied by law.
