ROAD TRANSPORT (SAFETY & TRAFFIC MANAGEMENT) ACT ITEMS FOR DETERMINATION

5.1 2025.RT.026 - Banyandah Street, South Durras – No Stopping Signs

RECOMMENDATION

That Council Plan 5490-X-01 plan to install signage at Banyandah Street and Boat Ramp Road, South Durras, be approved.

BACKGROUND

Council received a request from the Durras Progress Association for the installation of 'No Stopping' signs at the intersection of Banyandah Street and Boat Ramp Road, South Durras. At this intersection, during busy holiday periods vehicles are parked along the road reserve, forcing pedestrians to walk out on the road and affecting safe intersection sight distance for motorists turning out of Boat Ramp Road into Banyandah Street. The 'No Stopping' signage will be set back from the edge of the road to prohibit parking on an unsealed section of the road reserve. 'No Stopping' signage is in place on the opposite side of this intersection and this proposal will mirror that treatment. Installing 'No Stopping' signage at this intersection, will prohibit parking, improving pedestrian and vehicular safety.

CONCLUSION

Approval will enable placement of 'No Stopping' signage, improving pedestrian and motorist safety at the intersection of Banyandah Street and Boat Ramp Road, South Durras.

5.2 2025.RT.027 - Narooma Library Carpark, Narooma – No Parking Signs

RECOMMENDATION

That Council Plan 5490-Y-01 plan to install signage for Narooma Library, Narooma be approved.

BACKGROUND

Council rangers have requested that 'No Parking' signage be installed within the car park of the Narooma Library. Cars parking at this location are causing difficulty for vehicles entering and exiting into adjacent formal car parking spaces. There is currently informal 'No Parking' lettering painted on the car park surface, however the installation of signage will allow regulatory enforcement by Council rangers.

CONCLUSION

Approval will enable placement of 'No Parking' signage, improving pedestrian and motorist safety at the Narooma Library car park.

5.3 2025.RT.028 - George Bass Drive Roundabout, Malua Bay – Signage and Line Marking

RECOMMENDATION

That Council Plan to install signage and line marking at George Bass Drive – Sylvan Street – Kuppa Avenue roundabout, Malua Bay, be approved.

BACKGROUND

Council has been successful in securing grant funding of \$3.3 million under the NSW Government's fixing country roads program to construct a four-leg roundabout on George Bass Drive at the intersection with Kuppa Avenue and Sylvan Street. The design includes islands and paths within the roundabout to assist pedestrians and cyclists crossing the roads. There will be installation of new stormwater drainage and kerb and gutter along with upgraded lighting. The community will benefit from improved road safety, for motor vehicles, pedestrians and cyclists as well as improved efficiency and accessibility for the transport network.

CONCLUSION

Approval will enable placement of signage and installation of line marking, for the new roundabout on George Bass Drive, Malua Bay. Completion is expected in December 2025.

ITEM 6 - INFORMAL ITEMS FOR DISCUSSION

6.1 2025.SE.012 Lazer Rally of the Bay

RECOMMENDATION

That the submitted Traffic Guidance Scheme and Event Signage Plan for Lazer Rally of the Bay 2025 to be held on 2 August 2025, subject to approval by the NSW Police, and Transport for New South Wales, be approved.

BACKGROUND

The Lazer Rally of the Bay will take place on 2 August 2025. The rally will be held across roads within the Eurobodalla and Shoalhaven LGA's attracting approximately 500 attendees and visitors to the event. The event ceremonial start will take place at Corrigans Reserve, Batehaven. Road closures will be implemented on affected roads from one to two hours before the scheduled start of the first competitive vehicle. A safety car will then traverse the course three times prior to the start, ensuring safety and readiness of the course. Rally cars moving outside the staged areas will adhere to the NSW road rules at all times. A detailed Safety Plan and Traffic Management Plan have been submitted for this event.

CONCLUSION

Approval of the Traffic Guidance Scheme and Event Signage for Lazer Rally of the Bay 2025 will enable the event to proceed.


7.2 2025.RT.029 - Sunpatch Parade, Tomakin – Shared pathway signage


