# Appendix 1

## Catchment Analysis



---

## South Durras

A small community of 300+ urban lots with a significant tourist industry, it also includes two caravan parks and the Murramarang Resort.

### Existing Facilities

- A shared path runs from Village Road, across Durras Creek and through Durras Sportsground to Durras Drive
- A shared path along Durras Lake Drive.

### Identified Deficiencies

- Link from the Durras Lake Drive pathway to the Durras Lake boat ramp area
- Controlled crossing of Durras Drive at Durras Lake Drive
- Connection along Durras Drive from Durras Lake Drive to Durras headland and onto Allambie Street (identified by Durras Community Association)
- Lack of footpaths on key streets.

### Comment

South Durras services a small active community. It also supports three caravan parks/resorts which provide accommodation within the village. Consequently the population within South Durras fluctuates significantly throughout the year with consequent impacts on traffic and pathway user numbers.

Other than on the primary collector routes, traffic volumes within Durras village are low and therefore the existing streets are capable of being part of the network.

The community have worked pro-actively with Council, contributing funds to the provision of a shared path along Durras Lake Drive, connecting the two parts of the village.

The Durras community are seeking formalisation of a pathway connection from Durras Lake Drive to the headland, although there is a restriction at the bridge crossing of Durras Creek. This project will require detailed design and review of the environmental constraints.

### Recommendations (Map 1)

1. A shared path be provided along Lakeside Drive to the Durras Lake boat ramp
2. A road crossing facility or improved signage be provided at the Durras Drive/Durras Lake Road intersection
3. A footpath be provided along Durras Drive from Durras Lake Drive to Durras headland and onto Allambie Street
4. Footpaths be provided along Allambie Street, Banyandah Street and Corrilla Street.

## Long Beach and Maloneys Beach

### Existing Facilities

- Footpaths exist within Long Beach Estate as a result of subdivision development.

### Identified Deficiencies

- Long Beach continues to be a growth area with further urban and rural subdivision and consequent take up on vacant lots. The new subdivision areas have been provided with formal pathways.
- There are no formal pathways along the collector roads of Sandy Place, Long Beach Road or Northcove Road. Nor is there a pathway connection to the local Maloneys Beach shop. These roads are physically constrained and therefore footpaths are recommended.

### Comment

A public toilet has recently been added to the foreshore area on Sandy Place, Long Beach near the existing picnic facilities. A barbeque will be installed in 2016-17 working with the Long Beach Community Association. When the playground near Beatrice Place reaches the end of its useful life, it will be relocated to near the Sandy Place facilities, creating a cluster of recreation facilities. This will increase the importance of providing a linking pathway to this area.

The traffic volumes along Cullendulla Drive continue to increase. Council has secured funding under the 'Black Spot' program for the section of road from Kettle Road back to Blairs Road. This work will include provision of 2m wide sealed shoulders which will improve the safety of cycling. The remainder of Cullendulla Drive back to the Princes Highway will be progressively widened as funding becomes available.

The Long Beach Community Association has requested consideration of a link across Cullendulla Creek estuary. If constructed this would link Long Beach and Surfside by a pedestrian bridge over Cullendulla Creek with the potential to open up opportunities for a low key coastal route from Durras to Batemans Bay utilising existing tracks through the National Park and foreshore areas. The construction of such a bridge however would be a significant cost, requiring full investigation of the environmental issues and constraints. It would also need to address issues in providing appropriate linkage through, and to, the National Park. Further conversation should continue with the NSW Government to assess if it is prepared to build and maintain this connection to service the National Park.

### Recommendations (Map 2)

1. A footpath be provided along Maloneys Drive, Maloneys Beach from Northcove Road to connect residents to the Maloneys village shop
2. A footpath be provided along Northcove Road from Long Beach Road to Maloneys Drive and along Maloneys Drive to Hibiscus Place
3. A footpath be provided along Sandy Place from Sandy Place to Long Beach Road

4. A footpath be provided along Long Beach Road from the RFS Station to Bay Road.

## North Batemans Bay/Surfside

### Existing Facilities

- Footpath along the Princes Highway from the Batemans Bay Bridge to Kings Highway roundabout
- Shared pathway from the Princes Highway along Kings Highway connecting to Bayridge Drive, then on the western side of Bayridge Drive
- Footpath from Kings Highway to Highcliffe Road along Old Punt Road
- Shared pathway from Old Punt Road under bridge to Korner's Park and Wharf Road
- Shared path along Wharf Road/McCleod Street from the Princes Highway to Mundarra Way and on to Timbara Crescent
- Footpath along Mundarra Way to Batemans Bay Primary School
- Footpath from Batemans Bay Primary School to Palana Street
- Footpath along Peninsula Drive from the Princes Highway to Lincoln Crescent and also from the previous cul-de-sac of Peninsular Drive to Mundarra Way
- National Parks & Wildlife Service low key track and boardwalk at Surfside near Cullendulla Creek.

### Identified Deficiencies

- A missing link in the pathway on Peninsula Drive
- Existing path along the Princes Highway is narrow and widening is required to make it safer. The RMS has been approached to assist in addressing this issue.
- Need for a connection from the pathway linking to Palana Street from the primary school back to Timbara Crescent
- The community in the Palana Street precinct utilise a track adjacent to the school to access the Princes Highway, from where they connect to Batemans Bay. The path north from the Kings Highway roundabout ends abruptly at the culvert north of Peninsula Drive. People using this route walk on the shoulder of the highway.
- No pathways along the main collector roads (Berrima Parade, Wallarah Street, Foam Street/Timbara Crescent to Myamba Parade) or the bus route through Surfside.

### Comment

The Surfside sporting fields and the primary school are well serviced by connecting pathways. The network needs to be extended southwards to connect to Timbara Crescent to improve connectivity to the local shops at Surfside and Surfside beach.

There is also moderate use of the dirt track from the school back to the Princes Highway and then through to the pathway on the Highway north of Peninsula Drive. This pathway should be formalised to connect the Palana Street precinct to town.

An opportunity exists to extend the shared pathway to the Myamba Parade beach car park.

The RMS has been contacted and requested to provide a shared pathway from north of the motel on the Princes Highway to Wharf Road.

The current pathway on the Princes Highway north of Wharf Road is below desirable standards and should be upgraded to a shared pathway, in part due to the steep road fill batter on the Highway. This matter has also been referred to the RMS for consideration.

The subdivision north-west of the Kings Highway and Princes Highway intersection is having an impact on increased use of facilities. A connecting pathway has been provided to the subdivision with suitable crossing points on the Kings and Princes Highways provided via the two roundabouts. The on-going development of this area will continue to see a rise in the number of pedestrians and cyclists travelling to/from Batemans Bay and nearby recreational facilities.

### **Recommendations (Map 3)**

1. A footpath be provided on Peninsula Drive (note this is proposed to be constructed in the 2016-17 financial year)
2. A footpath be provided to main collector roads/bus routes including Berrima Parade, Wallarah Street, Iandra Road, Palana Street (Berrima Parade to Wallarah Street), Timbara Crescent (Palana Street pathway to Foam Street), Peninsula Drive and Old Punt Road
3. A shared pathway be provided along Foam Street, Timbara Crescent, Myamba Parade (Timbara Crescent to Wallarah Street) to complete the link to Myamba Parade beach car park
4. A footpath be provided from the primary school to Palana Street pathway through to Timbara Crescent
5. A footpath be provided from the primary school pathway through to the Princes Highway north of the motel
6. Council continue to advocate to the RMS to assist funding a shared pathway along the Princes Highway from north of the motel to Wharf Road.

## Nelligen

### Existing Facilities

- Nelligen Bridge
- Paths through the foreshore reserve adjacent to Wharf Street
- Path in Braidwood Street from access to Wharf Road serving commercial premises.

### Identified Deficiencies

- The village streets are typically low trafficked except for the town entry and foreshore streets which can be busy on weekends and particularly during holiday periods.
- There is no off-road footpath connection along Braidwood Street from the commercial precinct to Runnyford Road.
- The caravan park is on the northern side of the Kings Highway. Pedestrians cross the Kings Highway to walk to town and the adjacent hotel. There is currently no pedestrian facility to assist crossing the highway. This is a matter for the NSW Roads and Maritime Services (RMS) to consider. The pathway connection along the Kings Highway from the hotel to Reid Street is also a matter for the RMS and should be referred for consideration.

### Comment

Nelligen is a small village built on the Clyde River with a rich European history. There are shops, a playground and boating facilities on the foreshore as well as local tennis courts and a hotel and caravan.

The foreshore reserve on the west bank has been recently upgraded and is considered adequate for walking, providing good access for tourists arriving by boat to the shops.

Traffic volumes are such that the existing roads act as appropriate links for the network.

The RMS are considering a new bridge crossing of the Clyde River. Any new bridge should provide connections to both sides of Nelligen village. This has been raised with the RMS.

Access across the Kings Highway has been referred to the RMS for consideration in the Kings Highway Corridor Strategy review.

The Kings Highway east of Nelligen has now been upgraded by Council. as a contractor to the RMS. to include wide sealed shoulders (works funded by NSW Government).

### Recommendations (Map 4)

1. A footpath be provided connecting the Kings Highway into Braidwood Street
2. A footpath be provided from the shops along Braidwood Street up to Runnyford Road
3. The RMS be requested to address the pedestrian facilities required to cross the Kings Highway near the hotel and provide a pathway linkage back to Reid Street.

## Batemans Bay

### Existing Facilities

- Footpaths on all streets within the commercial centre
- Batemans Bay foreshore
- Beach Rd shared pathway.

### Identified Deficiencies

The main deficiencies remaining within this precinct include:

- Suitable connection from the end of Hill Street to Vesper Street (Princes Highway) near the Visitor Information Centre. This track is heavily utilised and is eroded due to the steepness of the track. This may require steps.
- Suitable crossing points across Beach Road, in particular at:
  - Perry Street intersection
  - Pacific and Herarde Street intersections
  - Hanging Rock regional sporting complex
- Pathways along the busier roads including South Street, Bavarde Avenue and the southern side of Beach Road (near Vesper Street)
- Pathway connecting to the Batemans Bay Hospital in Pacific Street from South Street
- Shared off-road pathways along the Princes Highway. This matter has been raised with the RMS and assistance requested to fund these works.

### Comment

Batemans Bay is a regional town centre with numerous facilities including main commercial precinct, industrial areas, town wharf, playgrounds, foreshore parks, boat ramps, pool, sports grounds, museum, community hall, Water Gardens, hospital and Batemans Bay Soldiers Club

Recent years have seen major upgrades to the pathway connections to the Batemans Bay CBD including Pacific Street pathway, connecting North Batemans Bay/Surfside and provision of additional pathways in Orient Street south/Old Princes Highway.

Council has also undertaken a pedestrian mobility action plan for Beach Road. This confirmed the deficiencies on Beach Road outlined above.

Suitable pedestrian crossing points have been incorporated into the proposed roundabout at Hanging Rock regional sporting and educational precinct (expected to be complete in 2016-17).

Council has secured an election commitment from the Australian Government to fund the upgrade of Beach Road from east of Perry Street to Vesper Street. This will include provision of traffic lights on the Perry Street intersection to assist with safe pedestrian crossing of Beach Road.

McKay Park is a major attractor for both pedestrians and cyclists, with it being the location of the aquatic centre, a mini-golf centre and the main playing field for the area. A link is required both along the access road and north along Vesper Street to the traffic lights at North Street and then onto the Bridge. Any path along the Princes Highway should preferably be a shared pathway.

There is no current connection between the CBD and the South Batemans Bay industrial area. This should be pursued, as well as further extensions south. This link would provide connection to the industrial area and onto the Batemans Bay Cemetery.

**Recommendations (Map 5)**

1. A footpath connection be provided from the end of Bent Street on top of the hill down to Hill Street/Vesper Street near the Visitor Information Centre. This may require steps.
2. A footpath be provided along Beach Road from the Perry Street roundabout to the Princes Highway (Vesper Street) on the southern side of Beach Rd.
3. Footpaths be provided along the Old Princes Highway, South Street and Bavarde Avenue to complete the circuit along this busy collector road
4. A footpath be provided along Pacific Street from South Street to the Batemans Bay hospital and from the Hospital to Short Street
5. Council continue to pursue grant funding for suitable intersection and road upgrades to improve safety of crossing Beach Road including:
  - i) Upgrades to Beach Road between Orient Street and the Princes Highway
  - ii) Upgrades to Beach Road with Pacific and Herarde Street intersections
6. Council to continue to advocate to the RMS to assist funding a shared pathway network to be constructed along the Princes Highway from the Bridge to the Batemans Bay cemetery including provision of access to the MacKay Park sporting precinct
7. All medium/high density residential, commercial/light industrial development be required to provide a pathway of the appropriate type along their property frontage as a condition of development consent where a suitable nexus exists.

## Catalina, Hanging Rock & Batehaven

### Existing Facilities

- Beach Road shared pathway
- Shared path along western side of George Bass Drive from Beach Road to Calga Crescent and Calga Crescent from George Bass Drive to Melaleuca Crescent
- Footpath along southern side of Beach Road from Bavarde Ave to George Bass Drive
- Footpaths in Correa Place, Protea Place and Oakwood Way.

### Identified Deficiencies

- No connecting pathway on the approach to the traffic lights on Catlin Avenue
- Lack of suitable crossing points across Beach Road, in particular at Hanging Rock regional sporting complex
- No pathway within Hanging Rock regional sporting and educational precinct
- No pathway on Country Club Drive (Sea Street to Heron Road) or Heron Road
- No pathways along the main through roads within Catalina
- Only a gravel surface on the pathway from George Bass Drive to Catalina Drive
- No connecting pathways within Yarrabee Estate noting footpaths exist within the subdivision
- Inadequate pathway connections to Batehaven CBD, St Bernards Primary School and Observation Point lookout.

### Comment

The Batehaven CBD and Corrigans Beach reserve are significant attractions for pedestrians and cyclists. Council is proposing a regional inclusive playground at Corrigans Beach reserve and viewing platforms at Observation Point lookout.

St Bernards Primary School is also a significant attraction and is currently lacking fully connecting pathways.

The construction of the South Batemans Bay Link Road will connect to Heron Road increasing the traffic volumes and potentially the speed of traffic on this urban road. Council should therefore include a separate footpath along this route and investigate the need for traffic calming devices to manage speed along Heron Road.

Previous requests have been made for a connecting pathway from Heron Road to Bavarde Avenue at the back of the golf course. A connection could be made from Heron Road to Gregory Street through a reserve although this pathway would lack natural surveillance as it would run through bushland. The use of the pathway is also likely to be low. Therefore this pathway is not supported at this time.

### **Recommendations (Map 6 & 7)**

1. Complete the Hanging Rock roundabout in 2016-17 with connections to the splitter islands to permit use as refuges for pedestrians and cyclists
2. A shared pathway be constructed within the Hanging Rock regional sporting and educational precinct (note this is planned to be complete in part in 2016-17 in conjunction with the central road reconstruction)
3. A footpath be provided on Catlin Avenue (Dolphin Avenue to Beach Road traffic lights)
4. A footpath be provided in Country Club Drive (existing footpath to Heron Road) and in Heron Road to take account of the anticipated increase in traffic from the proposed connection to the South Batemans Bay Link Road
5. A footpath be provided on the main route through Catalina along Sea Street, Vista Avenue, Ridge Street, Berrima Street, Derribong Avenue, and Calga Crescent
6. The existing gravel track be upgraded to a footpath between George Bass Drive and Catalina Drive (north of the BMX track)
7. A shared pathway be provided on Melaleuca Crescent from Calga Crescent to Yarrabee Drive
8. A footpath be provided on Melaleuca Crescent from Yarrabee Drive, and on Yarrabee Drive (Melaleuca Crescent to Melaleuca Crescent), and connecting to the existing footpath in Oakwood Way
9. A footpath be provided along Edward Road from the existing footpath south (note stage two of this pathway is proposed to be constructed in 2016-17 financial year)
10. A footpath be provided in Crag Crescent from the existing footpath to Joseph Street (note this footpath is proposed to be constructed in the 2016-17 financial year)
11. A footpath be provided in Ocean Road from Joseph Street to View Street and the construction of this pathway be considered in conjunction with reconstruction and kerb and guttering when due
12. A footpath be provided along View Street, Grantham Road, Sheila Street, Calton Road and David Street to connect with St Bernards Primary School, the church and retirement village
13. A footpath be provided along Observation Avenue to the proposed viewing platform.

## Sunshine Bay

### Existing facilities

- Shared pathway Sunshine Bay Road (part), and Hume Road (Sunshine Bay Road to Wills Crescent)
- Footpath along Beach Road from Short Beach Creek to Sunshine Bay Road adjacent to Sunshine Bay Primary School
- Footpath on Beach Road from Sunshine Bay Road to Hillview Place
- Footpaths within Sunshine Bay subdivisions
- Footpath eastern side of Burkes Way.

### Identified Deficiencies

- Lack of footpaths on Beach Road, a major regional road
- Incomplete linkage along Sunshine Bay Road back to Edward Road pathways
- Incomplete linkages from Sunshine Bay Estate back to Hume Road
- No formal connection from Sunshine Bay Road to John Oxley Crescent
- No footpaths in Cunningham Crescent, John Oxley Crescent, Thomas Mitchell Crescent near future commercial site
- Lack of connection from Valley Road to Hume Road.

### Comment

Sunshine Bay Primary School sits within this precinct along with other attractions such as nearby beaches.

There are a number of busy roads within this precinct without any pathways including sections of Sunshine Bay Road and Beach Road. These roads are also bus routes and should have pathways connecting residents to bus stops.

The proposed pathways should be designed to connect existing pathway networks such as those on Edward Road, Hume Road and Wentworth Avenue.

The reserve between John Oxley Crescent and Sunshine Bay Road is used as a short cut and should be formalised to allow a direct connection from the subdivision to the pathway in Sunshine Bay Road.

### Recommendations (Map 8)

1. The footpath be continued along Beach Road, Sunshine Bay south from Hillview Place to Valley Road
2. The shared pathway on Sunshine Bay Road, Sunshine Bay be built back to Edward Road intersection to complete the link
3. A linking footpath be provided from Sunshine Bay Road to John Oxley Crescent, Sunshine Bay

4. A linking footpath be provided along Cunningham Crescent, John Oxley Crescent, Thomas Mitchell Crescent, Sunshine Bay near future commercial site. This can be deferred until the developer proceeds. The developer should fund the pathway near the shops.
5. A footpath be provided on Wentworth Avenue, Sunshine Bay from Hume Road to the existing pathways in Sunshine Bay Estate subdivision
6. A footpath be provided to connect the end of Valley Road, Sunshine Bay to the Hume Road shared pathway.

## Denhams Beach / Surf Beach

### Existing facilities

- Footpath on Beach Road from Valley Road southwards (short length only)
- Footpath on Beach Road from Graydon Avenue to Surf Beach Reserve
- Footpath from Beach Road through Edgewater retirement village to Denhams Beach
- Footpath in Bligh Street (part only).

### Identified Deficiencies

- Lack of footpaths on Beach Road, a major regional road
- Lack of connection along Hume Road to the existing Burkes Way footpath
- Lack of footpaths along Beach Road near Explorers Way (refer also Beach Road within and south of Sunshine Bay Precinct)
- No footpath exists near the pre-school on Beach Road
- Limited footpath exists connecting the residential areas to Surf Beach shops
- Inadequate footpath connections to bus stops.

### Comment

There are a number of very busy roads within this precinct without any pathways including sections of Beach Road, Explorers Way and Surf Beach Avenue. These roads are also bus routes and should have pathways connecting residents to bus stops.

The Surf Beach shops and Surf Beach beach are major attractions in this precinct yet the pathways network has significant gaps which if filled would improve accessibility and road safety. Denhams Beach is also an attractant, albeit to a lesser degree than Surf Beach.

A footpath network should be provided to match the existing bus route.

Refer Appendix 3 for maps of existing and proposed pathways.

### Recommendations (Maps 8 and 9)

1. A footpath be provided on Beach Road from Valley Road to Burkes Way, Denhams Beach
2. A footpath be provided along Hume Road to complete the link to the Burkes Way footpath at Denhams Beach.
3. A footpath be provided on Beach Road, Surf Beach from Explorers Way to the bus stop just north and from the existing footpath at the shops south to Surf Beach Avenue
4. A footpath be provided on Explorers Way, Surf Beach (full length) to improve resident access to Surf Beach neighbourhood shops
5. A footpath be provided on Hume Road, from Explorers Way to Burkes Way, Surf Beach to connect back to the Hume Road pathway.
6. A footpath be provided on the bus route inclusive of part Cook Avenue, Pacific Road, Bligh Street, part Eric Fenning Drive and Surf Beach Avenue in Surf Beach
7. A shared pathway be provided along Beach Road, Surf Beach, south from Surf Beach Avenue to George Bass Drive.

## Lilli Pilli - Malua Bay - Rosedale

### Existing Facilities

- Footpaths within the new section of Lilli Pilli and Sea Breeze Estate subdivisions
- Shared path through Malua Bay Reserve from Kuppa Avenue to King Street
- Shared Path from The Ridge Road to Tallawang Avenue and then a footpath on to Malua Bay shops, including the footbridge over Reedy Creek
- Footpaths in front of Malua Bay shops.

### Identified Deficiencies

- Lack of pathways in Carramar Drive, Lilli Pilli and linking to Lilli Pilli beach, including crossing facilities at George Bass Drive
- Lack of connecting pathways from Carramar Drive, Lilli Pilli via Youralla Avenue to Mosquito Bay shops and boat ramp
- Lack of pathway facilities along George Bass Drive, Malua Bay between Baringa Crescent and The Ridge Road shared pathway
- Lack of pathways in Tallawang Avenue, Malua Bay
- Lack of pathway connections along Sylvan Street, Malua Bay between George Bass Drive and recent subdivisions.

### Comments

Significant development has occurred over recent years in the Lilli Pilli and Malua Bay areas. While some of the subdivisions, in particular those constructed within the last 10 years, have had footpaths provided, there is a lack of formal connections in some areas.

The Malua Bay shops and main beach including Batemans Bay Surf Club are a major attraction. Future consideration should be given in the medium-term to construction of a roundabout at the George Bass Drive/Sylvan Street/Kuppa Avenue intersection to reduce speed in this vicinity.

The Malua Bay Bowling Club is another significant attraction.

Similarly the Mosquito Bay shop/café and boating/foreshore area is a significant attraction. George Bass Drive will require upgrade in this vicinity prior to constructing the pathways.

The section of pathway north of The Ridge Road will require consideration of the future road layout in this vicinity including provision for an intersection at Link Road. The section of pathway between The Ridge and Link Roads is proposed to be built in 2016-17.

Despite the footbridge at Reedy Creek being narrow, there is not sufficient demand to replace this structure at this time.

There is a lack of a footpath on Rosedale Parade. To service current residents and future residents within the Rosedale expansion lands, a footpath should be provided.

**Recommendations (Map ref 10, 11 & 13)**

1. A footpath be provided on Carramar Drive, Lilli Pilli from Bunderra Circuit to George Bass Drive
2. A suitable crossing facility for George Bass Drive near Carramar Drive, Lilli Pilli be investigated to aid pedestrians and cyclists accessing the Lilli Pilli beach footpath, and a pathway be built to Lilli Pilli beach over/near the existing track
3. A footpath be provided from Carramar Drive, Lilli Pilli via Warragai Place, the reserve pathway and Youralla Avenue through to George Bass Drive, Malua Bay
4. A shared pathway be provided along George Bass Drive, Malua Bay from Fairview Drive Crescent to The Ridge Road, giving consideration to the future needs and reconstruction of George Bass Drive including intersection treatments and pedestrian crossing facilities
5. Footpath links be provided from Sea Breeze estate subdivision on Link Road and The Ridge Road back to George Bass Drive
6. A footpath be provided on Garagarang Street, Malua Bay between Yugura Street and Iluka Avenue, and then Iluka Avenue to connect to the future George Bass Drive pathway network
7. A footpath be provided on Tallawang Avenue, Malua Bay from George Bass Drive to the beach access opposite Garagarang Avenue
8. A shared pathway be provided along Sylvan Street, Malua Bay from George Bass Drive to Elandra Place with connections to the existing pedestrian refuges on George Bass Drive
9. A footpath be provided along the west side of George Bass Drive, Malua Bay south from Sylvan Street to the existing bus shelter.
10. A footpath be provided along Rosedale Parade, Rosedale from George Bass Drive to the beach.

# Mogo

## Existing Facilities

- Pathways along both sides of the Princes Highway (Sydney Street) from near Bateman Avenue to Tomakin Road then to Mogo Public School
- Charles Street, Mogo accessible car space to Tomakin Road.

## Identified Deficiencies

- Mogo Public School fronts the Princes Highway. Parking occurs on both sides of the Highway. There is a connecting set of pedestrian activated traffic lights across the Princes Highway, however there are some gaps in pathway linkages between where people park and the traffic lights. This may encourage people to cross the Highway away from the traffic lights. This issue will be raised with the RMS.
- Mogo Public School utilises Mogo Sportsground for sporting and recreational activities. However there are no formal pathways to the oval along Church Street or Park Street, Mogo.
- Charles Street car park is provided to service the Mogo CBD area. However there are no formal pathways linking the car park to the CBD.
- There are two informal linkages from the car park through private property which confers a commercial advantage for the shops who have provided this arrangement within their own land.

## Comment

Mogo has a busy shopping precinct on the Princes Highway, Old Mogo Town, a primary school and local sports ground.

Council proposes constructing a gravel pathway connecting the northern end of Charles Street car park to Annett Street in 2016-17. In time, this will be replaced with a roadway connecting the car park and Annett Street.

Formal pathways should also be provided to connect the Charles Street car park along Tomakin Road. Liaison with the RMS should be undertaken prior to construction to confirm future plans to upgrade the Princes Highway/Tomakin Road intersection as this may impact the alignment along Tomakin Road.

The pathways within the CBD are asphalt and were provided in keeping with the village. They are adequate for the task however consideration should be given to converting these to reinforced concrete should the pathways be renewed.

Refer Appendix 3 for maps of existing and proposed pathways.

## Recommendations (Map 12)

1. A gravel pathway be provided connecting the northern end of Charles Street, Mogo car park to Annett Street. This is planned for 2016-17.
2. A footpath be provided connecting the Charles Street, Mogo car park to the Princes Highway via Tomakin Road and Annett Street

3. All new commercial development fronting the Charles Street car park be required to provide a footpath on their frontage to Charles Street car park (both sides)
4. A footpath be provided along the east side of the Princes Highway, Mogo from Bateman Street south to the existing footpath
5. Any development on the Princes Highway, Mogo be required to provide a footpath along its frontage and where appropriate, a connection to the existing footpath network
6. Council to continue to advocate to the RMS for assistance in funding the design and construction of additional kerb and gutter with footpaths near the Mogo Public School to further improve safety around the primary school
7. A footpath be provided along Church Street/Park Street, Mogo to link the public school to Mogo sportsground.

## Tomakin, Mossy Point, Broulee

### Existing Facilities

- Shared pathway from The Moorings boundary along George Bass Drive to Tomakin Road including pedestrian refuge facilities to aid crossing of George Bass Drive at Tomakin
- Shared pathway from Sunpatch Parade to the Tomakin Sport and Social Club entrance, Tomakin
- Shared pathway fronting part of Jack Buckley Park, Tomakin
- A footpath connecting Ainslie Parade to Sunpatch Parade, Tomakin
- A footpath connecting the car park on Ainslie Parade to the Tomakin Hall
- Footpaths within the new Barlings Beach subdivision at Tomakin
- A footpath on Annetts Parade from Surfside Avenue to Beach Road and along Beach Road to Candlagan Creek bridge at Mossy Point
- Shared pathway network along Coronation Drive, Grant Street and Heath Street, Broulee
- Footpaths along Train Street and Cambridge Avenue serving Broulee Primary School, St Peters Anglican College and the two pre-schools
- Footpaths within the new subdivisions within Broulee
- Old South Coast Road – gravel road to Airport environs and North Head campground.

### Identified Deficiencies

- Lack of pathways within Tomakin connecting the Club, Jack Buckley Park, the beaches and the Tomakin Hall to other residential areas
- Lack of pathway connection from Council pathway to The Moorings development (within developer's property)
- Lack of pathways connecting to the local shop in Mossy Point
- Lack of footpaths connecting the new subdivision pathways to the existing network
- Lack of footpaths connecting to Captain Oldrey Oval complex.

### Comment

Tomakin, Mossy Point and Broulee are all coastal villages with a variety of attractants including local shops, cafes, beaches, viewing platforms, playgrounds, skate park, caravan park, Captain Oldrey sports ground Broulee, one primary schools and two combined high/primary schools.

Recent works in and around Tomakin, Mossy Point and Broulee have made a significant difference to the safe walking and cycling environment within these villages. This included connecting the retirement home in Broulee to the main beach and associated viewing platform (built since).

The community have worked pro-actively with Council, contributing funds to help build the Coronation Drive and Heath Street shared pathways in Broulee.

This strategy proposes improved pathway linkages within these three villages, including to new subdivision pathway networks by specific routes.

A footpath is proposed along Ainslie Parade, Tomakin to Yarralumla Crescent to provide safer pedestrian movement over the crest of the hill back to the Tomakin Hall and other pathways to assist residents access key locations within the village.

The community has previously expressed a desire for a separate off-road pathway along George Bass Drive to link Tomakin and Mossy Point. This has been able to be provided to the boundary of The Moorings development. The remainder of this pathway to the shops is the developer's responsibility. There are a number of significant restrictions to this proposal beyond that including the bridge, sensitive coastal and other forested environments. Therefore this proposal is not recommended to be pursued at this time.

There is adequate sealed shoulders along George Bass Drive for cycling between the villages. Additional signposting should be investigated particularly near the Tomaga River bridge to warn motorists of cyclists on the road.

Any development of the land on the east side of George Bass Drive near Annetts Parade should access back to Annetts Parade to ensure appropriate vehicular, pedestrian and cyclist access back into Mossy Point/Broulee.

The Broulee masterplan for future subdivision should include suitable pathways on all new streets including a shared pathway along the Heath Street extension and appropriate traffic management to lower the speed environment within the new urban precinct. These pathways will be provided by the developer.

Refer Appendix 3 for maps of existing and proposed pathways.

### **Recommendations (Maps 14, 15 & 16)**

1. Complete the shared pathway links along Sunpatch Parade back from the Tomakin Sport and Social Club/Jack Buckley Park to the beach and boat ramp area, and Melville Point Reserve Road at Tomakin
2. A footpath be provided on Ainslie Parade, Tomakin from the Tomakin Hall to Yarralumla Crescent and back along Yarralumla Crescent connecting to the new subdivision
3. A footpath be provided in Red Hill Parade from Ainslie parade to Melville Point carpark
4. A footpath be provided along Annetts Parade, Mossy Point from Connells Close to Surfside Avenue
5. A footpath be provided along Surfside Avenue and Pacific Street, Mossy Point to the local shop/café
6. A footpath be provided on Zanthus Drive, Broulee from the public access pathway off Caitlin Crescent to Train Street to connect the new subdivision pathways back to schools and the remainder of the pathway network
7. A shared pathway be constructed along Francis Street, Broulee from the Broulee Shared Path to Captain Oldrey Park reserve complex, and within the oval precinct once the car parking is upgraded

8. A footpath be constructed from the Woolabar Drive pathway along Woolabar Drive/Imlay Street back to the Grant Street shared pathway, past the existing tennis courts.
9. A footpath be constructed in Grant Street, Broulee from Heath Street north to the shops.

## North Head

### Existing Facilities

- Sealed shoulders (part)
- Off road gravel track from Broulee behind beach to the northern end of the airport

### Identified Deficiencies

- Currently, the track from Broulee to the airport (Old South Coast Road) finishes at the northern end of the airport. It is desirable that this linkage be completed through to the North Head campground and airport terminal. Given the relatively low cost of this linkage for the benefit gained, this proposal is supported.

### Comment

Council proposes to construct the off-road gravel shared pathway connection from the northern end of the airport to the North Head campground using funds provided by the Broulee Mossy Point Community Association and Council in 2016-17.

In recent years Council has also widened the previously narrow section of North Head Drive from east of the Quarry across the Malabar weir structure, making on-road cycling much safer. The construction of a separate pathway from the airport back to Moruya is not economically viable given the significant physical constraints.

Refer Appendix 3 for maps of existing and proposed pathways.

### Recommendations (Map 18)

1. A gravel off-road shared pathway be provided from the northern end of the airport to North Head campground to connect the existing gravel track from Broulee (note this work is planned for 2016-17)
2. Review route signposting on North Head Drive to assess if further 'share the road' signs are warranted

## Moruya

### Existing Facilities

- Gundry Oval Criterion Track
- Shared path along River Street/Moruya River/Shore Street, Ford Street and adjacent to Princes Highway linking from Moruya Hospital to Moruya TAFE
- Shared path north side of Campbell Street, Moruya from Vulcan Street to Ford Street
- Shared path along west side of the Princes Highway, Moruya from John Street to Albert Street (including road crossing) then along Albert Street to the Moruya High School
- Shared path along Shore Street, Moruya from Thomas Street to Church Street with links to the Criterion Track
- South Head Road, Moruya – shared path from the Princes Highway to Keightley Street
- Moruya CBD pathways
- Footpath in Campbell Street, Moruya from Vulcan Street westwards to Hawdons Road
- Footpaths in Albert Street, Evans Street (part), Bergalia Street (part), Turnbills Lane (part), Swan Ridge Place, Patterson Close, Murray Street (part), Vulcan Street, Heffernan Place, Thomas Street (part)
- Footpaths within the new Braemar estate subdivision, Moruya
- Gravel shared path through Moruya Golf Club.

### Identified Deficiencies

- No connecting pathway from Heffernan Place, Moruya footpath to Shore Street pathway
- Gap in Murray Street pathway back to Evans Street and Thomas Street, Moruya
- Lack of pathway connecting Campbell Street, Moruya to Gundry Oval car park, toilet and playground on Evans Street
- Lack of pathways in Page Street, Moruya connecting to Church and Murray Street networks
- Pathway across Moruya Golf Club is gravel only
- Missing links in Evans Street, Bergalia Street, Thomas Street, Luck Street, Keightley Street, Moruya
- Lack of crossing facilities across South Head Road at Keightley Street, Moruya.

### Comment

Moruya is a main town centre with a CBD, light industrial area, central hospital, foreshore reserve network and extensive sporting facilities at both Gundry Oval and the Showground as well as a Golf Club and Bowling Club. Moruya also has a town wharf, pool and Riverside Park.

Analysis of the existing pathway network has identified a number of opportunities for further development to address the identified deficiencies.

On-road cycling outside of the town is anticipated given the flat nature of the land. Where practicable, sealed road shoulders have been provided and this approach is supported.

The RMS has been approached to further develop wide sealed road shoulders between Moruya and the North Moruya industrial area to encourage cycling to work along the Princes Highway.

Council has previously widened South Head Road and North Head Drive to provide for safe on-road cycling opportunities within the constraints available.

An off-road shared pathway has been constructed in Moruya from the Princes Highway to Keightley Street. It is proposed to provide a suitable crossing facility across South Head Road to improve the connection of the shared pathway to residents in Keightley Street.

Council should consider conversion of the existing gravel path through the Golf Course to a concrete path and an extension through the Showground to Albert Street.

Refer Appendix 3 for maps of existing and proposed pathways.

### **Recommendations (Map 17)**

1. A footpath be provided on the Princes Highway north of Moruya River bridge connecting the caravan park and Service Station back to the bridge
2. A footpath be provided on the eastern side of the Princes Highway north of North Head Drive connecting the residential properties back to the bridge
3. A footpath be provided along North Head Drive, Moruya connecting residents back to the Princes Highway
4. A footpath be provided on Murray Street, Moruya connecting Thomas Street back to the pedestrian facilities for school children in Evans Street (note this project is funded in the 2016-17 program)
5. A footpath be provided in Evans Street, Moruya to the car park/playground in Gundry Oval from Campbell Street
6. A footpath be provided in Evans Street, Moruya connecting the existing footpath at Albert Street to the existing footpath on Bergalia Street
7. A shared pathway be provided on Bergalia Street, Moruya from Dwyers Creek Road to the Princes Highway/John Street
8. A footpath be provided on the Princes Highway, Moruya from Vulcan Street to Southlands shop driveway
9. A footpath be provided in Page Street, Moruya connecting Murray Street to Campbell Street and Queen Street to Church Street pathways (adjacent to St Marys Primary School)
10. A footpath be provided to connect the Murray Street , Moruya footpath to the existing footpath in Thomas Street
11. A footpath be provided in Thomas Street to connect the Heffernan Place, Moruya footpath to Shore Street shared pathway
12. A footpath be provided in Luck Street, Moruya from Hawdon Street to Yarragee Road and on Araluen Road to the Moruya Council Depot

13. Footpaths be provided within the Moruya CBD by developers when redeveloping commercial property as a condition of development consent
14. A pedestrian refuge be provided at Keightley Street, Moruya on South Head Road to improve the safety of crossing for pedestrians and cyclists
15. A footpath be provided in Keightley Street, Moruya connecting existing residents and future subdivision land
16. The gravel shared pathway across Moruya Golf Club from Vulcan Street be upgraded to concrete with suitable arrangement through to the Albert Street pathway network.

## South Head - Congo

### Existing Facilities

- South Head shared pathway from The Anchorage to Moruya Surf Club
- On-road cycling from South Head to Moruya.

### Comment

South Head has a number of attractions including the boat ramp, caravan, shop, popular beaches and surf club.

The community have worked pro-actively with Council, contributing funds and undertaking works to help provide a shared path from The Anchorage to the shop on Charles Moffitt Drive, South Head.

The shared pathway on South Head Road may be able to be extended to Halyard Drive. This would be subject to investigation of land acquisition and environmental approvals.

The extension of an off-road shared pathway from the caravan park would connect this important tourism accommodation back to the pathway network and to the shop via Charles Moffitt Drive, South Head. This would also provide a pathway connection back to the patrolled swimming beach.

The construction of a separate pathway for pedestrians from South Head to Moruya would be costly and require land acquisition and environment approvals with appropriate off-sets, therefore this proposal is not supported. 'Share the road' advisory signs have been provided along South Head Road to warn motorist of cyclist on the road.

Congo is a quite village with tourism supported by the National Parks & Wildlife Services camping ground within the National Park. Traffic is typically low volume.

The provision of a footbridge across Congo Creek to connect Pedro Point Road and Congo is not supported due to the high cost.

Refer Appendix 3 for maps of existing and proposed pathways.

### Recommendations (Map 18)

1. A shared pathway be provided along South Head Road, South Head from Halyard Drive to the Anchorage
2. A shared pathway be provided along Pedro Point Road, South Head from the caravan park to Charles Moffitt Drive.

## Tuross Head

### Existing Facilities

- Tuross Head shared pathway around the foreshore from Kyla Oval to the Tuross Head boat ramp including two boardwalks and gravel pathway section (below Coila Avenue to Anderson Avenue)
- Footpaths leading into the shopping centre including from Island View Road and Grenville Avenue cul-de-sac connection to Marlin Street
- Footpath in Trafalgar Road from Sandy Point to Jutland Avenue.

### Identified Deficiencies

- Lack of pathways along distributor and collector roads within the town
- Lack of pathways connecting to existing shopping centre
- Lack of a formal shared pathway connecting the existing shared concrete pathway below Coila Avenue to Anderson Avenue
- Lack of linking pathway from boat ramp pathway to Sandy Point.

### Comment

Tuross Head is an attractive coastal community with its own local shops, cafes, beaches, viewing platforms, memorial gardens, sporting complex, community hall, playgrounds, boating facilities, and golf and bowling club.

The community have worked pro-actively with Council, contributing funds and undertaking works to build the foreshore pathways in Tuross Head.

The formal linkage between the existing shared pathway (below Coila Avenue to Anderson Avenue) will be provided by the developer when the adjoining land is subdivided as a reinforced concrete shared pathway. Council will continue to maintain the gravel pathway until that time.

Refer Appendix 3 for maps of existing and proposed pathways.

### Recommendations (Map 19)

1. A footpath be provided along Hector McWilliam Drive, Tuross Head from Lake Street to Allenby Road
2. A footpath be provided along Anderson Avenue, Tuross Head with a connection back along Andrew Avenue to the pre-school
3. A footpath be provided along Hector McWilliam Drive, Tuross Head between Allenby Road and Trafalgar Road/Hawkins Road
4. A footpath be provided along Hawkins Road, Tuross Head
5. A footpath be provided along Trafalgar Road, Tuross Head between Hector McWilliam Drive and Jutland Ave
6. A footpath be provided along Craddock Road, Tuross Head between Hawkins Road and Clive Court

7. A footpath be provided between the boat ramp access and Sandy Point adjacent to Nelson Parade, Tuross Head
8. A footpath be provided along Allenby Road, Tuross Head from Hector McWilliam Drive to Monash Avenue and from along Monash Ave to Tuross Boulevard
9. A footpath be provided along Beach Street and Marlin Street, Tuross Head from Allenby Road to Evans Street and along Evans Street to the shops, and from the shops to Hawkins Road
10. A footpath be provided along Grenville Avenue, Tuross Head from the existing footpath to Marlin Street
11. A footpath be provided through the public reserve between Green Place and Swordfish Street, Tuross Head.

## Bodalla and Potato Point

### Existing Facilities

- Footpath along the Princes Highway from Potato Point Road north to Sutcliffe Street
- Shared pathway along the Princes Highway from Eurobodalla Road to the Rural Fire Service (RFS) shed
- Pedestrian Refuge on the Princes Highway at Sutcliffe Street
- Footpaths along the Princes Highway through the shopping precinct
- Pathway along Potato Point Road from the Princes Highway to the Bodalla primary school.

### Identified Deficiencies

- No pathways on Sutcliffe Street or Eurobodalla Road, Bodalla
- No pathway along the Princes Highway, Bodalla from Potato Point Road or the back of the primary school to Bodalla Oval.

### Comment

Bodalla is a small urban village on the Princes Highway. The main attractants include local shops, cafes, bowling clubs, primary school and sports ground.

An opportunity exists to improve the pathway network within Bodalla village particularly along the Princes Highway.

Additional pedestrian refuges should be provided to aid crossing the Princes Highway near the Bodalla Dairy Shed and between Sutcliffe Street and Potato Point Road. Council should continue to advocate on behalf of the Bodalla community to the RMS to fund the design and installation of these facilities.

Eurobodalla Road also carries significant truck movements and residents fronting this road have no easy pedestrian access back into town. Any pathway construction in this area should be undertaken in conjunction with reconstruction and kerb and guttering of Eurobodalla Road.

A formal pathway connection along the Princes Highway from Potato Point Road or from the back of the primary school to Bodalla Oval would be desirable. However this requires further investigation including options to fund the works.

No formal footpaths are considered required within the Potato Point Village.

Refer Appendix 3 for maps of existing and proposed pathways.

### Recommendations (Map 20)

1. A footpath be provided along Eurobodalla Road, Bodalla west of Sutcliffe Street in conjunction with the reconstruction and kerb and guttering of Eurobodalla Road
2. A connecting footpath be provided on Sutcliffe Street, Bodalla from Eurobodalla Road to the Princes Highway pedestrian refuge
3. A shared pathway be provided from the existing shared pathway on the Princes Highway, Bodalla between the RFS shed and Sutcliffe Street

4. Council to continue to advocate to the RMS to fund and install additional pedestrian refuges to aid crossing the Princes Highway near the Bodalla Dairy Shed, and between Potato Point Road and Sutcliffe Street
5. A pathway be provided from the existing footpath outside the Post Office south to Gannons Point Road
6. Council to further investigate a pathway connection along the Princes Highway, Bodalla between Potato Point Road and/or the back of the primary school to Bodalla Oval.

## Dalmeny – Kianga - North Narooma

### Existing Facilities

- Dalmeny-Kianga - Narooma shared pathway
- Narooma Boardwalk
- Footpath through reserve linking Brou Court, Tarouga Place and Binalong Street, Dalmeny
- Shared pathway along Noble Parade, Dalmeny from shops to the retirement village/Ocean Parade
- Footpath along Yabbarra Drive, Dalmeny
- Footpath along Warbler Crescent (part) and Creighton Place, Dalmeny
- Shared path from Mill Bay to the Princes Highway, North Narooma
- Footpath westwards along Riverview Road, North Narooma from the Princes Highway
- Stairs from Riverview Road to Hillcrest Crescent, North Narooma
- Underpass at the northern end of Narooma bridge.

### Identified Deficiencies

- No pathway along Binalong Street, Dalmeny to the sports field or connecting to the existing pathway at Attunga Street
- No pathway connection to the Dalmeny industrial area from the shared pathway
- No pathway along Ruth Place, Dalmeny connecting to the shared pathway. This should be provided by the Illawarra Retirement Village upon any further development of this site.
- No pathway connections from the residential areas of Thompson Parade, Dalmeny to the foreshore pathway
- No pathway on the southern side of Mort Avenue, Dalmeny connecting to the shops
- No pathway in Cresswick Parade, Dalmeny connecting the residential areas to the shops
- No pathway along Noble Parade, Dalmeny (busy collector road and bus route)
- No crossing facilities on Dalmeny Drive, Eucalyptus Drive/Barkala Street to connect to the bus stop or shared pathway
- No connecting pathway/crossing facility from Lakeside Drive, Kianga to the foreshore shared pathway
- No connecting pathway/crossing facility from Surf Beach Road, Kianga to the foreshore shared pathway
- No connecting pathway along Dalmeny Drive from Surf Beach Road, Kianga to the neighbourhood shops
- No connecting pathway along Dalmeny Drive from the Warbler Crescent (east), Kianga residential precinct to the foreshore shared pathway
- No connecting pathway along Dalmeny Drive, Kianga from Warbler Crescent (west) to Warbler Crescent (east)
- No connecting pathway along Riverview Road from the existing pathway to Lavender Point Road/Fishermans Crescent.

### **Comment**

Dalmeny and Kianga are coastal villages. The main attractants include local shops, cafés, Dalmeny Sport ground, bowling club, camping ground, beaches, viewing areas, community hall tennis courts and light industrial area.

The Dalmeny-Kianga-Narooma shared pathway has been completed, providing cycling and walking opportunities along the coastline and connecting these villages. An opportunity exists to further improve this pathway network by improving the connections from residential precincts to the foreshore pathway network through short lengths of pathway and appropriate crossings of Dalmeny Drive.

Within the Dalmeny and Kianga villages there is the Dalmeny sporting precinct, neighbourhood shops and an industrial area. These would also benefit from connecting pathways.

A number of other opportunities exist to improve the connectivity of residents to the network and these are outlined in the recommendations below.

Refer Appendix 3 for maps of existing and proposed pathways.

### **Recommendations (Maps 21 & 22)**

1. A footpath be provided from Mort Avenue, Dalmeny into the Dalmeny industrial area from the existing shared pathway
2. A footpath be provided on Ruth Place, Dalmeny to the existing shared pathway (by Illawarra Retirement Village)
3. A footpath and suitable crossing facilities be provided in the vicinity of Goolara Avenue, Dalmeny to improve the connection to the shared pathway on Mort Avenue
4. A footpath be provided along Binalong Street, Dalmeny from Mort Avenue to the Dalmeny Oval complex and then onto Attunga Street footpath
5. A footpath be provided along Thompson Parade, Dalmeny from John Reilly Street to Mort Avenue to connect this residential precinct to the foreshore pathway
6. A footpath be provided on the south side of Mort Avenue, Dalmeny from Thomson Parade to Cresswick Parade shops
7. A footpath be provided along Cresswick Parade, Dalmeny from Ernest Street to Lonsdale Parade and then down to the Dalmeny shops
8. A footpath be provided along Lonsdale Parade, Dalmeny from Cresswick Parade to Laidley Street
9. A footpath be provided along Noble Parade, Dalmeny from Mort Avenue to Amhurst Street, and then along Amhurst Street to the shared pathway on Dalmeny Drive
10. A footpath be provided along William Street, Dalmeny from Noble Parade to Ocean Parade
11. A footpath and suitable crossing facilities be provided in the vicinity of Eucalyptus Drive and Barkala Street, Dalmeny to improve the connection to the shared pathway on Dalmeny Drive

12. A footpath and suitable crossing facilities or improved signage be developed to connect Lakeside Drive and Surf Beach Road, Kianga to the shared pathway network on Dalmeny Drive
13. A footpath be provided along Dalmeny Drive, Kianga from Surf Beach Road to the neighbourhood shops and onto Viewhill Drive, Kianga
14. A shared pathway be provided along Dalmeny Drive, North Narooma connecting Warbler Crescent (east) to the shared pathway at Centenary Drive
15. A shared pathway be provided along Dalmeny Drive, North Narooma connecting Warbler Crescent east and west
16. A footpath be provided within the walkway reserve between Creighton Parade and Beachview Close, North Narooma
17. A footpath be provided along Riverview Road from the existing footpath to Fishermans Crescent and then Lavender Point Road.

## Narooma

### Existing Facilities

Narooma has an extensive network of pathways along the foreshore and within its CBD areas. Highlights include:

- Shared pathway around the Narooma foreshore and connecting to Bill Smyth Oval and Moruya swimming pool
- Pathways connecting to the Narooma Golf Club, primary school, caravan park, main beach
- Shared pathway connecting the Surf Club to the shopping centre on Willcocks Avenue
- Footpath networks within the CBD and along the Princes Highway
- Shared pathway to Narooma High School
- Footpath connections to Narooma Primary School
- Shared path from Narooma Wharf to Quota Park along Wagonga Foreshore
- Footpath along Riverside Drive Quota Park to Bettini Lane, Narooma
- Shared path along Bluewater Drive and McMillan Road to Barker Parade, Narooma
- Shared path along Willcocks Avenue, Narooma
- Narooma High School link
- Footpaths within CBD
- Footpath along Field Street from the Princes Highway to the Narooma library
- Shared pathway along Field Street from the Narooma Library to Riverside Drive
- Footpath in Graham Street, Narooma
- Footpath in Burrawang Street, Narooma from the Princes Highway to Graham Street
- Footpath in Forsters Bay Road, Narooma from the Princes Highway to Thomsen Walkway
- Footpath along Bluewater Drive, Narooma from Narooma Wharf to the Golf Club and then along Ballingalla Street to Surf Beach access
- Footpath in Bowen Street, Narooma from the Princes Highway adjacent to the Narooma Bowling Club to Campbell Street
- Footpath along Montague Street, Narooma from the Princes Highway to the public school and golf club
- Footpath along Tilba Street, Narooma from the Princes Highway to Sheaffe Street
- Accessible footpath from Bluewater Drive to Wharf Street/Campbell Street, Narooma
- Pedestrian refuges on the Princes Highway between Burrawang and Field Streets, adjacent to the Visitors' Information Centre near McMillan Road, via the Princes Highway/Bluewater Drive roundabout, and near Forsters Bay Road
- Pedestrian refuge in Bluewater Drive, Narooma between the Princes Highway and foreshore/pool connecting the Narooma Leisure Centre car park and NATA oval.

### Identified Deficiencies

- No adequate crossing of the Princes Highway at Riverside Drive exists, limiting the usefulness of the foreshore route and breaking the linkage of the two parts.

### **Comment**

Narooma is a main town centre with three main shopping precincts, light industrial area, cafes, sports grounds, pool, leisure centre, beaches, viewing platforms, surf club, golf club, Soldiers Club, playgrounds, skate park, town wharf, caravan parks, primary school and high school.

The Narooma foreshore and flat shared pathways are well developed as are many other pathways that connect key community facilities and shopping areas.

There are however a number of opportunities to further improve the pathway network and these are outlined below.

An opportunity does exist to extend a foreshore pathway back from the end of Lakeside Drive to Gem Crescent cul-de-sac and then onto Dorothy Drive cul-de-sac. This should be further investigated to assess the environmental constraints. If viable this does offer a flat, safer option for residents in these precincts to walk/cycle back to the Narooma foreshore and all of the facilities within this area.

### **Recommendations (Map23)**

1. A footpath be provided along the Princes Highway, Narooma from the existing footpath north to the shared pathway on Riverside Drive
2. Council continue to advocate to the RMS to provide a suitable intersection upgrade with a pedestrian refuge at the Princes Highway/Riverside Drive intersection, Narooma
3. Footpaths be provided for the full length of Graham and Burrawang Streets, Narooma
4. A footpath be provided in Canty Street and Bowen Street, Narooma linking the existing paths and carparking
5. A footpath be provided along Barker Parade, Narooma connecting the McMillan Road shared pathway to the footpath in Forsters Bay Road
6. A footpath be provided along Marine Drive, Narooma from the Princes Highway to Ballingalla Street shared pathway
7. A footpath be provided along Davidson Street, Narooma
8. A footpath be provided along Riverside Drive from Davidson Street to Bettini Lane
9. A footpath be provided in Tilba Street, Narooma from Sheaffe Street to Ballingalla Street
10. A footpath be provided along Glasshouse Rocks Road from Princes Highway to Hopkins Place
11. A footpath be provided along the service road for Princes Highway, Narooma from opposite Glasshouse Rocks Road to Old Highway, Narooma
12. A footpath be provided along Old Highway, Narooma from Old South Coast Road to Cole Crescent
13. A foreshore pathway be investigated to connect Lakeside Drive to Gem Crescent, Narooma

14. A foreshore pathway be investigated to connect Gem Crescent to Dorothy Drive, Narooma.

## Mystery Bay, Tilba and Akolele

### Existing Facilities

- Footpaths along Bate Street through Central Tilba village.

### Identified Deficiencies

- Lack of pathway from Whiffen Lane.

### Comment

Central Tilba and Tilba Tilba are historic villages whilst Mystery Bay and Akolele are small coastal hamlets.

A footpath along Corkhill Drive, Central Tilba from Whiffen Lane to Bate Street should be provided, connecting residents to the village.

The construction of a separate pathway to the primary school is problematic due to the steep terrain and rock in this vicinity. The preferred arrangement is for the school bus to continue to transport the children from the school to town.

### Recommendations (Map 24)

1. A footpath be provided along Corkhill Drive, Central Tilba from Whiffen Lane to Bate Street.








**Map 1: Durras**




**Map 2: Long Beach – Maloneys Beach**


**Map 3: North Batemans Bay / Surfside**




































