MORUYA SOUTH HEAD CYCLE/PATHWAY COMMITTEE PRESENTATION ORDINARY COUNCIL MEETING 22 MAY 2018

Madam Mayor, Councillors, General Manager, Council Staff, Members of the Gallery and live stream viewers,

- 1. We commend council for continuing to work towards the safe off road shared pathway from Moruya to the beach, as this was always our shared aim.
- 2. We note that the project, with this new funding, is in the early stages. The committee, however, requests that it be involved in the process by way of regular, say 3 monthly, briefings. This will work to inspire the committee and community to finish the shared pathway.
- 3. It is heartening, when driving along South Head Road, to see the elderly, dog walkers, mothers with prams, cyclists and family groups etc. using the already completed sections of this wonderful council asset.
- 4. We are committed to continue to fundraise and pursue grants in our own right.
- 5. The committee remains eternally grateful to the Hon Andrew Constance who made this funding available. It has enabled the next phase to start immediately and the groundwork for subsequent stages to be put in place.
- 6. Under recommendation, point 3, of the report, the committee and I would like to clarify that John Seltenrych and I played no role in gaining this grant funding was not due to our direct advocacy.

There are a few questions we wish to ask Mr Warren Sharpe:

Council's previously resolved motion 17/209 is referred to in this report. How does this affect the continuation of the Moruya South Head Cycle/Pathway Project?

Council should be aware however, that Council has previously resolved (Motion 17/209) as follows:

THAT:

1. Council adopt the Eurobodalla Pathways Strategy June 2017 attached to this report, subject

to the following amendments:

i) In Appendix A1-24 the wording be changed to read as follows:

The Moruya to South Head off–road pathway linkage will be reconsidered when the pathways strategy is next reviewed in five years, unless the project is fully funded through grants (outside of the Active Transport Program) and/or community funding'.

2. At this stage does Council have any estimate how much funding will be left over for pathway construction next financial year?

The funding offered will be sufficient to:

- i) complete the section identified within the adopted Eurobodalla Pathways Strategy 2017 from east of The Anchorage to Halyard Drive
- ii) undertake the detailed design, environmental approvals and land acquisition for the section between Keightley Street and Halyard Drive, and prepare estimates for the whole of the project
- iii) allow commencement of work from Keightley Street toward South Head. Upon completion of the above work, Council will be able to re-assess further stages against other priorities across Eurobodalla.
 - 3. Can you explain the route, including crossovers, the shared pathway will take along South Head Road and the reasons why please?
