His timing was impeccable, and saw The Beagle become a very popular place to get community news, and let's face it, have a dig at Council.

In recent years, this group of councillors had enjoyed a more productive relationship with The Beagle and we were always grateful for Lei's honesty about our performance.

He published without fear or favour, like good media should.

Council's communications team has had an enduring relationship with Lei, and while they didn't always agree, Kellee tells me the relationship was always respectful, robust exchanges were the norm and expected, and plenty of laughs were had.

The Beagle, with Lei as its publisher, editor and solo reporter, provided a unique way for Eurobodallans to get their news.

"Just one guy and a laptop" he was known to say, but what he produced was a place for residents to explore their own community – crucial glue in good times and bad.
