

Eurobodalla water restrictions for businesses and organisations



Water restrictions are enforceable and apply to all Eurobodalla water users including residents, visitors, businesses and organisations. Restrictions may be subject to change.

If your business or organisation uses water outdoors and is not on this list, please phone Council on 4474 1000 to check which water restrictions apply to you.
